Completed Tender documents must be placed in a plain sealed envelope and be clearly marked with the Notice No: 129/2015, **UPGRADE OF CRADOCK MAIN RECEIVING STATION AND NETWORK** and be placed in the Municipal Tender Box, Supply Chain Management, Inxuba Yethemba Municipality Building, Cradock, before **11h00** on **09 December 2015**. Tenders will be valid for 90 days from this closing date.

TENDERERS SHALL TAKE NOTE OF THE FOLLOWING BID CONDITIONS:

- An approved formal surety will be required.
- Failure to complete all supplementary information may result in the tender being null and void or non-responsive.
- Tenderers must have a proven track record in the installation of indoor MV switchgear and MV Cable installation and terminations, miniature substations including LV installation into buildings.
- Tenderers are required to be registered for VAT and will need to submit an original SARS Tax Compliance Certificate with their tender in order to be considered.
- Penalties for late completion will be enforced.
- The Contract Value is in CIDB Grade 5EP PE or 5EB PE Category or higher. Proof of registration to be attached.
- Preferential Procurement Policy Framework Act (PPPFA) and the Inxuba Yethemba Local Municipality Supply Chain Management Policy will apply.
- The Inxuba Yethemba Municipality does not bind itself to accept the lowest or any other Bid and reserves the right to accept the whole or part of the Bid
